DESCRIPTION OF REQUIREMENTS

1. The United Nations Peacekeeping Force in Cyprus (UNFICYP) intends to conduct a competitive solicitation exercise for the design, construction, commissioning and testing of solar farm OP38, South East of Aulona, Nicosia, Cyprus.

2. Observation Post 38 (35° 9'31.02"N, 33° 6'34.59"E) is administered under UNFICYP Sector 1, UN buffer zone, South-East of Aulona (Gayrektöy) village, on flat ground. The facilities are currently connected to the Electrical Authority of Cyprus (EAC).

3. The Contractor shall perform the services in three (3) consecutive phases, Phase 1: Study and Executive Design, Phase 2: Mobilization, Supply and Installation and Phase 3: Commissioning and Testing. The minimum objective is to design and install on-grid PV system with a minimum capacity of 18.36 kilowatt-peak.

4. Interested vendors shall have the opportunity to attend the mandatory site visit, as part of the solicitation exercise.

5. In this regard, UNFICYP would like to identify vendors that would be interested to participate in the competitive solicitation exercise.
