Annex

Draft Decision regarding the conditions of service of the members of the Commission on the Limits of the Continental Shelf

The Meeting of States Parties,

Noting the importance of the delineation of the outer limits of the continental shelf beyond 200 nautical miles and that it is in the broader interest of the international community that coastal States with a continental shelf beyond 200 nautical miles submit information outer limits of the continental shelf beyond 200 nautical miles to the Commission on the Limits of the Continental Shelf, andwelcoming the submissions to the Commission by a considerable number of States Parties to the Convention on the outer limit to their continental shelf beyon 200 nautical miles, that the Commission has continued to fulfil its role, including making recommendations to coastal States, and that the summaries of recommendations are being made publicly available

Reaffirming the importance of the work of the Commission for coastal States and the international community as a whole amounting with appreciation the continued efforts undertaken by the Commission to consider the submissions by coastal States in a timely, efficient was manner,

Recognizing the need to ensure that the Commission can effectively perform the functions entrusted to it under the Convention, while maintaining its high level of quality and expertise,

Recognizing the significant workload of the Commission in view of the large number of submissions received, which places significant demands and challenges on its members and the Secretariat as provided by the Secretageneral through the Division for Ocean Affairs of the Sea of the Office of Legal Affairs

Expressing conce**a**bout the implications of the workload of the Commission for the conditions of service of its members.

- 2. Reaffirms the obligation of Statesarties under the Convention whose experts are serving on the Commission to defray the expenses of the experts they have nominated while in performance of Commission duties, including the provision of medical coverage, and urges these States to do their utmost to ensure the full participation of those experts in the work of the Commission, including the meetings of subcommissions, in accordance with the Convention;
- 3. Emphasizes the importance of the voluntary trust fund established by the General Assembly pursuant to resolution 55/7 in facilitating the participation of members of the Commission from developing States in the meetings of the Commission, and expresses its appreciation to States that have made contributions to this trust fund;
- 4. Reiterates itsserious concern that the chronic underfunding of the trust fund referred to in paragraph 3above may preclude the Commission from advancing its work as a result of the potential lack of a quorum at future sessions, and may prevent it from further impleting the decision of the twenty-sixth Meeting of States Parties that requested the Commission to meet for up to 26 weeks, and urges States, international financial institutions, donor agencies, intergovernmental organizations, norgovernmental organization
