

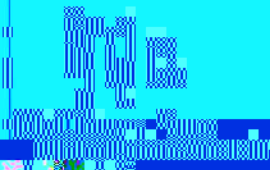

**ARTICLE 1
Status of the Parties**

1. Neither Party nor its personnel shall have

contemplated by Articles 1 and 2 of this MOU, both Parties, their employees and contractors shall keep strictly confidential all information and materials, relation to this MOU, and/or provided by one Party to the other Party. Neither the United Nations, nor ISIT, shall disseminate any such confidential information.

either Party may terminate this MOU for cause, upon thirty (30) days written notice to the other Party, or otherwise self-terminate, at the expiration of the MOU.

3. This MOU shall enter into force upon signature by both Parties and shall be in effect for two years.

ARTICLE 8 Settlement of Dispute

1. **AMICABLE SETTLEMENT:** The Parties shall use their best efforts to amicably settle any disputes, controversy, or claim arising out of this MOU.



2. ARBITRATION Any dispute, claim or controversy, whether arising out of or in connection with this MOU, order the termination of the MOU, or any other measure taken by the Parties with respect to this MOU, shall be referred to and resolved by arbitration in accordance with the provisions of Article 26 ("Interim Measures of Protection") and Article 32 ("Form and Effect of Award") of the ICDR Rules of Arbitration and Conciliation, 2012, as amended, which are incorporated by reference into this MOU, the arbitral tribunal shall have the authority to award interest on the amount of the award at the rate of 12% per annum, compounded annually, from the date of the award until the date of payment of the award. The award shall be rendered as a result of such arbitration shall be final and binding on the Parties.
