#### Information on the NGO list of speakers

NGOs that were scheduled to speak today, 23 April 2009, and have not had the opportunity to take the floor, should pick up **ground floor speakers badges** from the list of speakers desk outside E3062 on **Friday, 24 April 2009**, from 8:00 a.m. onwards.

Please note that **25 copies of the oral statement are to be made available and handed to <u>conference</u> <u>services staff</u> (located to left-hand side of the podium when facing it and to the opposite side of the NGO list of speakers) at the beginning of the meeting. Photocopiers are available outside conference room XVII.** 

To take the floor, NGO speakers should use the 2 conference-table seats reserved for that purpose and speak within the time-limit of 3 minutes allocated to them.

Copies of NGO oral statements may be placed by NGOs on the table reserved for this purpose outside the Salle des Assemblées <u>only</u> (exit to left-hand side of the podium when facing it) after delivery of the relevant statement. NGOs are not permitted to distribute documents, pamphlets or any other material in the conference room. Reserved desks are available for display of NGO documentation outside conference room XVII.

#### Side events

A number of meeting rooms have been made available for the organization of side events with requests received by the Secretariat by 14 April, for participants accredited to the Conference. Such events will be held daily during the period of the Review Conference at the Palais des Nations.

The OHCHR as part of the program of side events is hosting a number relating to the Durban Declaration and Programme of Action.
