ItCs high time for us to try and strengthen efforts to achie, e the ob:ecti, e of putting in place a global legal frame - ork in the form of 1 omprehensi, e 1 on, ention on International *errorism to counter a global scourge. *his - ill pro,ide a legal basis for global fight against terrorism as all Member States - ill ha, e a multilateral platform to counter terrorism.

%\$. 6urther, - e all need to - ork together to e8pose and destroy the linkages that e8ist bet - een terrorists and their supporters. We need an international mechanism to ensure accountability and :ustice, enhanced dialogue and broaden understanding amongst Member States. While the threat emanating from international terrorism is looming large, the inability of the 3nited ?ations to agree on a 1omprehensi, e 1on, ention on International *errorism remains one of the most glaring shortcomings in the international legislati, e frame - ork - hich could ha, e boosted enforcement efforts to destroy safe ha, ens of terrorists, their financial flo - s and their support net - orks.
