Statementby H.E. Mr. Kyaw Moe Tun, Permanent Representative of the Republic of the Union of Myanmar to United Nations under agendaltem 84: The Rule of Law at the National and International Levels, at the Sixth Committee of the Seventy-Seventhsession of UN General Assembly (New York, 7 October 2022)

Mr. Chair,

As this is the first time that I have taken the floor, I wish to congratulateyou on your election as the Chair of the Committee I assureyou and the Bureau of our full support and cooperation.

Mr. Chair,

This committee must know that thidegal overthrow of a democratically elected government is a flagrant violation of the rule of law. Such unlawful acts should never be acceptable the international community.

The rule of law is maintained through the separation of power and the checkslances between the branches of governments because the independence of the judiciary

However, in my country of Myanmar, the unwantentilitary leader, who has no regard for the rule of law and enjoys blanket impunity so far himself the absolute authority and executive, legislative and judiciapowers through the illegal couphe has criminally arrested the elected Presidentand other members of the governmenthe illegal junta has neither legal basits regitimacy.

Yet the illegitimate juntahas been making o-called laws to suits needs, arbitrarily enforcing them as they wis Right now, no court independently adjudicates the law. They only rubber stamphe orders of the humane military.

These lawless acts of the military juntagre evidence by the absurd secretials against ure elected civilian leader including President U Win Myint, State Counse Dog WAung San SuuKyi, and agains of the military his lding hostage.

As a result, the rule of law in my country beeing buried and remendous injustice is being inflicted on the people. This is what is happen in might now, in Myanmar.

Since the coup, Myanmar people have been facing military brutality at massive scale including multiple massacres, who scale arson of civilian homes and deliberate attacks against towns, villages and school by air strikes.

Just last month, a military helicopter swooped downlocal school in Let Yet Kone Village in Depayin Township in Sagaing Regional brutally killed at least 13 people including seventhildren who were darning and playing innocently.

These horrifying crimes are blatant violations of international anumights and humanitarian law.
