





B. On 21 December 2015, the Resolution Board, pursuant to Article 7 of the UNDT Statute, issued Case No. 2015/0!2.

5. Case No. 2015/035 and Case No. 2015/0!2 were assigned to the same arbitrator for the sole purpose of the present award.

### Consideration

1. The Arbitrator, as revealed by the affidavits filed with the Resolution Board, is not in a position to conduct a full and complete review of the award of the Resolution Board under Article 15 of the UNDT Statute. Pursuant to Article 15 of the UNDT Statute, the arbitrator in Case No. 2015/035 and Case No. 2015/0!2, the arbitrator, pursuant to the terms of the arbitration agreement, has conducted a review of the award of the Resolution Board and has issued an award in Case No. 2015/035 and Case No. 2015/0!2. The arbitrator, therefore, is not in a position to conduct a full and complete review of the award of the Resolution Board under Article 15 of the UNDT Statute.

D. The arbitrator is free to award damages to the claimant for the loss of profits, interest and costs of litigation, as well as to award punitive damages to the claimant.
