<u>Description</u>: The discussion organized by the Global Partnership for the Prevention of Armed Conflict (GPPAC) and Interpeace, in partnership with the Permanent Mission of Norway to the United Nations, will provide an informal learning space for the representatives of local peacebuilding organizations, the bilateral and multilateral donor communities, and the private sector to develop a common understanding of peacebuilding funding opportunities and impact, thereby working towards identifying modalities best suited to realistically and sustainably achieving locally-led determination of impact. In this, the discussion will feed into the 2025 Peacebuilding Architecture Review by highlighting some avenues to measure the impact and adjust existing peacebuilding programming by strengthening the global commitments, across different sectors, on financing for peacebuilding.

During the discussion, the participants will be asked to reflect on the following questions:

How can new financing approaches enable locally-led determination of impact? What significant changes in the modalities of grant-based financing are realistic? How would innovative financial instruments curate better quality peace impacts?

How do we strengthen a shared understanding of innovative financing structures? How can donors, governments, private sector, civil society adopt a new mindset for more impactful peacebuilding finance? How to ensure that investments are credibly peace-positive?
