Excellency,

I have the honour to write to you regarding the selection and appointment of the Secretary-General. As you recall, guided by the principles of transparency and inclusivity, the President of the Security Council and I jointly circulated a letter dated 5 February 2021 which set in motion the process of selecting and appointing the Secretary-General.

To date, the name of one candidate, the incumbent Secretary-General Antonio Guterres presented by Portugal, has been circulated to Member States in my joint letter of 26 February together with the President of the Security Council.

Further to that letter, I am pleased to circulate the attached vision statement submitted by Mr. Guterres. The vision statement will also be posted on the page on my website dedicated to the selection and appointment of the Secretary-General. In resolution 69/321, the General Assembly decided to conduct informal dialogues or meetings with candidates for the position of Secretary-General. This provision was fully implemented during the 2016 selection and appointment process, with all candidates participating in an informal dialogue with the General Assembly. Each candidate also submitted a vision statement.

Committed to upholding the implementation of this provision for the current cycle of selection and appointment as well, it is my intention to hold the first of the informal dialogues on 7 May 2021 at 10.00 am in the General Assembly Hall. Should further candidates be presented in accordance with resolution 69/321, additional dates may be scheduled. Further details on the modalities of the informal dialogues will be circulated in due course.
