We have already made some progress, particularly in appointments of women at the most senior levels: the number of women at or above ASG level has gone from 21 in 2007 to 38 in 2011. However, this rate of growth has not been sufficient to reach parity with men. At the P-2 level, women represent 53 per cent of our total workforce in the Professional and higher grades, ranging from a high of 53 per cent at the P-2 level to a low of 24 per cent at the D-2 level. Further, the historic growth at the highest levels has been contrasted with the low rate of growth

Therefore, I call personally on all Heads of Departments, Offices and Missions to accelerate progress towards gender parity in their areas, particularly at those levels which have the least improvement, namely the D-4 to D-1 levels.

Finally, may I remind you that my Compact with senior managers contains two indicators to explicitly measure and account for progress in the enhanced representation of women at all levels, including, in particular, the middle level.
